Having perused:

The Constitution;

and Decree Law no.22 /2014 on the Regulation of Presidential Elections;

and Presidential Elections Committee Decree no. 1 /2014 on the Rules Governing the  
Committee's Exercising of its Competences;

and to Presidential Elections Committee Decree no. 6 /2014 on the Regulations Governing  
the Observation of the 2014 Election for the President of the Republic by Foreign and  
International Civil Society Organizations;

and Presidential Elections Committee Decree no.15 /2014 on the Regulations of Media  
Coverage for the 2014 Election for the President of the Republic;

and to Presidential Elections Committee Decree no. 19 /2014 on Accepting the Applications  
of Foreign and International Civil Society Organizations Interested in Observing the  
Presidential Election 2014;

and Presidential Elections Committee Decree no. 20 /2014 the Acceptance of Media  
Coverage Requests Submitted by Media for the 2014 Presidential Election;

and upon the approval by the Presidential Elections Committee on its session held on  
Wednesday the 28<sup>th</sup> of April 2014;

**Decided:**

**Article (1)**

The time of observers registration set forth in article (6) in Presidential Elections Committee  
decree no.6 /2014 on the Regulations Governing the Observation of the 2014 Election for  
the President of the Republic by Foreign and International Civil Society Organizations shall  
be extended to Monday 5<sup>th</sup> May 2014, and further the time of issuing the accreditation cards  
set forth in the same article shall be extended to Tuesday the 20<sup>th</sup> of May 2014.

**Article (2)**

The time of registration set forth in article (3) in Presidential Elections Committee decree  
no.15 /2014 on the Regulations of Media Coverage for the 2014 Election for the President  
of the Republic shall be extended to Saturday the 3<sup>rd</sup> of May 2014, and further the time of  
issuing the accreditation cards set forth in article (4) of the same decree shall be extended to  
Thursday the 15<sup>th</sup> of May 2014.

**Article (3)**

This decree shall be published in the Official Gazette and shall be enforced starting from the day following the date of its publication.
