# Presidential Elections Committee Decree no. 29 /2014

On the Regulations of Formation of the Committee for Receiving & Examining Complaints

## **Presidential Elections Committee,**

Having perused:

The Constitution;

and Decree Law no. 22 /2014 on the Regulation of the Presidential Elections;

and Decree Law no. 1 /2014 by Presidential Elections Committee on the Rules Governing the Committee's Exercising of its Competences;

and upon the approval by the Presidential Elections Committee on its session held on Sunday the 11<sup>th</sup> of May 2014;

#### Decided:

## Article(1)

The committee for receiving complaints shall be formed in the Presidential Elections Committee:

Under the presidency of Judge Dr./ Abd El-Aziz Salman, General Secretary of The Presidential Elections Committee,

## And the membership of:

- 2- Judge/ Tarek Abd El-Aleem

- 7- Judge/ Ahmed Hassan Said Bendary

- 9- Judge/ Mohamed Raslan
- 10- Judge/ Yasser El-Mabady
- 11- Judge/ Ahmed Refaat
- 12- Judge/ Sara Adly Hussein

The committee may request a sufficient number of the administrative staff working with The Presidential Elections Committee.

## Article (2)

The committee shall undertake the receiving of all complaints in relation to the electoral process that will conduct on the 26<sup>th</sup> and 27<sup>th</sup> of May 2014. It shall examine them and take the necessary decisions in response to them. If need be, the committee shall present them before The Presidential Elections Committee.

## Article (3)

The committee may request assistance from co-coordinators from:

- 13- The Ministry of Interior
- 14- The Ministry of Defense
- 15- The Ministry of Foreign Affairs
- 16- The Ministry of Information
- 17- The Ministry of State for Administrative Development

## 18- The National Council for Human Rights

It may demand the assistance from other competent authorities that shall nominate their relatives representatives.

### Article (4)

A manual register shall be established for recording complaints coming to the committee in any way either by telephone, E-mail, fax, or mail; all procedures that are taken concerning such complaints shall be registered .

Documents received by the committee shall be kept according to order complaint was registered thereof in the register determined for that purpose.

## Article (5)

This decree shall be published in the Official Gazette and shall be enforced starting from the date of its publication, and the General Secretariat of the Presidential Elections Committee shall implement it.
