On the Timeline for the 2018 Presidential Elections

The President of the Authority

Upon review of the Constitution;

and Law No. 22 of 2014 on Regulating Presidential Elections;

and the Law on Regulating the Exercise of Political Rights promulgated by Law No. 45 of 2014;

and Law No. 198 of 2017 on the National Election Authority;

and Presidential Decree No. 503 of 2017 on Establishing the Board of Directors of the National Election Authority;

and Decree No. 1 of 2018 of the National Election Authority on Calling on Voters to Elect the President of the Republic;

and upon approval of the Board of Directors of the National Election Authority in its session held on 8 January 2018

Has decided: Article 1

The Presidential Elections of 2018 shall be held according to the attached timeline.

Article 2

This Decree shall be published in the Official Gazette and in Al-Ahram and Al-Akhbar newspapers and the competent authorities shall be responsible for its execution.
